An article by Mark Niesse of the Atlanta Journal Constitution explains:

"A lawsuit supported by Democrat Kamala Harris' presidential campaign challenged new Georgia election certification rules Monday, warning that they will 'invite chaos' if the results are disputed. The case takes aim at rules approved by the State Election Board's Republican majority that require an undefined 'reasonable inquiry' and add requirements before county election boards finalize results one week after Election Day.

The <u>44-page suit</u> by the Democratic Party says the rules could lead to disputes over the vote count and potentially delay certification. At least 19 county election board members have <u>refused to certify</u> various elections since 2020, according to a statewide survey by The Atlanta Journal-Constitution.

'Certifying an election is not a choice, it's the law,' said Quentin Fulks, principal deputy campaign manager for the Harris-Walz campaign. 'A few unelected extremists can't just decide not to count your vote.'

The lawsuit escalates the fight over Georgia's election rules, which were passed by three right-wing members of the State Election Board this month after they were praised by Republican presidential nominee Donald Trump as "pit bulls fighting for honesty, transparency and victory" during an Atlanta rally.

Georgia is one of the key battleground states in the upcoming election. We will continue to watch this issue closely as it progresses through the judicial system.

IVF AND REPRODUCTIVE HEALTHCARE ACCESS

On July 17th, I hosted a webinar with my friend and colleague **Dr. Robin Fogle**, a reproductive endocrinologist and a fertility specialist in Atlanta, about the practice of IVF and the legislative landscape around its practice.





When I host these educational webinars, I always make it a point to invite all lawmakers, across both parties, and from both chambers of the legislature, and my goal is simple. *I think we do a better job when we understand more about the issues on which we're legislating*. And lack of understanding of reproductive healthcare is one of the key areas that have led to unintended consequences in states across the nation, including Georgia.

Of course, the reason we even need to have conversations about imperiled access to IVF is because states like <u>Louisiana</u> and <u>Alabama</u> have recently made efforts to restrict the practice. In all, <u>at least 13 states have pending legislation that</u> threatens IVF treatment.

In our webinar, Dr. Fogle and I discussed specifics of the practice of IVF, the push from conservative groups like the <u>Southern Baptists</u> and <u>Project 2025</u> to constrain IVF, and what we in the Georgia General Assembly can do to protect patients who simply seek to start or grow their families.

One thing would be to pass bills like **HB 1497**, which my Democratic colleagues and I cosponsored last session, unfortunately without the support of a single member of our Republican majority.

HOUSE STUDY COMMITTEE ON ALTERNATIVES TO OPIOIDS

As a practicing anesthesiologist, I have spent decades working on pain control, opioid risk mitigation, and alternative methods for acute and chronic pain treatment. I'm honored to have been chosen by Speaker Burns to participate on the <u>House Study Committee on Alternatives to Opioids for Pain Management</u>, chaired by Rep. Katie Dempsey.



In our <u>first meeting</u>, we discussed the state of the opioid epidemic in Georgia, availability of naloxone, access to mental health and medication-assisted treatment for opioid use disorder, and the status and allocation of Georgia's Opioid Settlement funds.

I look forward to our next meetings, and to our written report which may help guide our **legislative and non-legislative approaches to opioid risk abatement.**

GUN VIOLENCE PREVENTION

From our Listening Tour I know that **gun violence continues to be at the top of mind for many residents of House District 50**, and as such we have continued to work post-session on advancing gun safety efforts and legislation. I feel lucky we have such strong partners advocating at the national level, and few are as vocal as our <u>Congresswoman Lucy McBath</u>. Her powerful <u>speech at the Democratic National Convention</u> was a moving reminder of how personal an issue this can be for so many of us, and why we keep fighting.



I am proud to note that I serve on the steering committee for a consortium of state legislators focused on the issue of gun violence, and working together we hope to pool strategies and advance legislation that can meaningfully move the needle on this issue, **even in states like Georgia where gun safety legislation has historically been quite difficult to advance.**

It is my hope that my bills from last session—in particular the <u>Pediatric Health</u> <u>Safe Storage Act</u> and the <u>Safe Storage Tax Credit Act</u>—might continue to move forward in 2025, as the majority of voters, including in Republican districts, demand progress.

Of course, **some of the strongest proponents for gun safety are not lawmakers at all**. In fact, many of them are doctors, parents, or both, people who understand intimately the toll gun violence can take on families. I was proud to speak on this panel with the <u>Georgia Chapter of the American Academy of Pediatrics</u> on the importance of physician involvement in legislative advocacy, and how much it makes a difference.



Working with a coalition of doctors called **Clinicians for Gun Safety**, we were able to meaningfully advocate for the advancement of both the Pediatric Health Safe Storage Act and the Safe Storage Tax Credit Act this past session, mostly because we were able to **correctly frame gun violence not as a political issue**, **but a public health issue**.



I look forward to continued work with these dedicated clinicians when we return to the Capitol in 2025!

SOUTHERN AIDS COALITION, HEALTH DISPARITIES

It was an honor to be invited by the <u>Southern AIDS Coalition</u> to speak on a panel at <u>The Carter Center</u> on health access disparities for patients living with HIV.







Georgia is the state with the highest new diagnoses of HIV. It is also one of only ten states in the nation that have thus far refused to fully expand Medicaid under the Affordable Care Act. One point I made on the panel was that it was difficult for me to see how serious work on prevention, diagnosis, and treatment of HIV and AIDS can fail to take into account our large uninsured population and the barriers to care these patients face.

TRI-CAUCUS TOWN HALL

Georgia, a majority-minority swing state, could again determine the results of the Presidential election. We also, for the first time, have a Black and South Asian woman at the top of the ticket, a fact that has invited a lot of discussion about racial identity, intersectionality, and politics.



I was proud to be part of our second ever **Tri-Caucus Town Hall** on July 17th, with leaders from **Georgia's Legislative Black**, **AAPI**, **and Hispanic Caucuses**. Some topics we covered included our personal backgrounds and how they inform our approach to politics, coalition work, what it means to us to hear someone derisively referred to as a "DEI hire," AP African American Studies as a curricular offering in GA, and much much more.

It was a valuable discussion among friends and community members--I hope the first of many such events!

WHITE COAT CEREMONY

I was honored to deliver the keynote last month at the <u>White Coat Ceremony</u> for the VCOM Master of Health Science for Anesthesia Class of 2026!



The White Coat Ceremony is now the traditional start to a student's career in medicine, and was first introduced at my alma mater, the <u>Columbia University College of Physicians and Surgeons</u>. It has since become a standard part of medical training around the country. I was especially proud to speak at the white coat ceremony for our anesthesiology masters students, as I work with so many excellent AA-Cs as we take care of patients together in the OR.

Anesthesiology is about providing care to patients when they need care most. Congratulations to all our new students, and welcome to the team!
